The Ph.D Course Work examination of all Faculties (excluding Department of Civil Engineering, Women Studies, Journalism & Mass Communication, Microbiology/Biotechnology and Library & Information Science) will be held during the month of April 2017. The detailed time table will be announced in due course. The fee prescribed are as below:

a. Ph.D Course Work Examination fee	:	Rs. 2,200/-
Foreign National	:	Rs. 4,400/-
b. Marks Card fee	:	Rs. 200/-
c. Application fee	:	Rs. 50/-

The Full time Karnataka SC/ST students [other than UGC, RGNF, CSIR, Women Scientist (DST), INSPIRE, Part-time Scholars, FIP/QIP/on deputation with full salary whose parents annual income is less than or equal to Rs.2,50,000/- per annum shall pay only the marks card and application fee. These students shall compulsorily apply for fee reimbursement to Social Welfare Department (SWD). The SWD will reimburse the fees prescribed. In case if the student does not apply for the fee reimbursement or in case of non-receipt of scholarship for whatever reasons mentioned therein by the SWD, the concerned student shall pay the all prescribed fee.

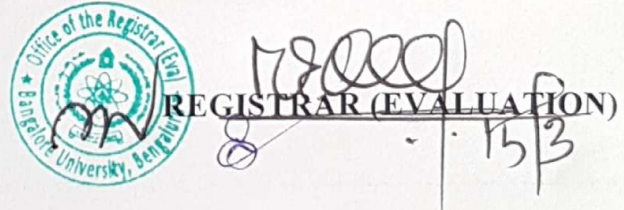
The last date for payment of examination fees and submission of Ph.D Course Work examination application forms to the concerned Departments are as follows:
