**NOTIFICATION**

**Sub:-** Grant of onetime permission to appear for failed subjects in all PG/UG Law & Engineering (Annual & Semester Schemes) – reg.

**Ref:-** 1. Resolution of the Academic Council at its meeting held on 18.10.2016.

Pursuant to the resolution of the Academic Council at its meeting held on 18-10-2016, one time permission is hereby accorded for U.G & P.G students **except Medical & Dental courses** to appear for the examinations in the failed subjects only and who could not complete their degrees within the maximum stipulated period, which is double the course duration, as per Bangalore University Regulations of respective courses subject to the following conditions.

1. a) Such candidates shall be permitted to appear for failed subjects in case of UG courses whenever respective semester Examinations are conducted by the University i.e., even semester during May/June 2017 and odd semester during November/December 2017 and whenever Annual scheme Examinations are conducted.
- b) In case of P.G course, such candidates may be permitted during December 2016 January 2017 (Odd semester) & May/ June 2017 (Even Semester).
- c) In case of LLB 3 and 5 year courses (odd & even) they will be granted permission in Dec 2016/January 2017 exams. (Maximum course durations for 5 and 3 year LLB are 10 and 6 years, respectively).
- d) The Engineering courses Examination will be conducted sometime during 2017.
2. All such candidates shall study and pass the Examinations/subjects **as per the existing syllabus only.**
3. The Annual scheme Examinations of both UG & PG courses will be conducted along with Examinations of Correspondence & Distance Education courses of Bangalore University.

4. Candidates should have fulfilled 75% attendance in all the semesters/years as per University Regulations during their course time and the candidates **who have discontinued the course are not-eligible** to appear in this one time measure scheme.
5. Candidates shall pay the Examinations fee whenever the fee notification is issued by the University for the relevant semesters/ years.
6. This permission is a **one-time measure** and should not be quoted as a precedent and no further requests will be entertained under any circumstances in this regard.
