Examination applications may be obtained from the Office of the Directorate of Correspondence Courses, Jnanabharathi Campus, Bangalore University, Bengaluru.

Dully filled in applications with fee receipt, true copies of marks cards, recent passport size photo etc., should be submitted to the Directorate of Correspondence Course, Jnanabharathi Campus, Bangalore University, Bengaluru on or before the dates mentioned above. No other way of submission of applications will be entertained.

The University will not be responsible for the loss or otherwise of examination forms sent in any other manner. No refund will be made on payment of Examination fee and submission of application for the Examination, if he/she is not otherwise eligible to take the Examination as per Rules /Regulations governing the eligibility to take the Examination.

Students whose admissions are not approved by the University shall not be permitted to pay the Examination fee and submit the applications for the Examination.

In case, any candidate is permitted to write the examination without admission approval, the Directorate of Correspondence Courses will be doing at their own risk and their results will not be announced.

The Directorate of Correspondence Course & Open University should send the candidates list of Freshers and Repeaters separately with a certificate that they are found Eligible for Registration to the respective course of study duly approved by the Registrar. The list of Repeaters who are eligible be made separately and sent along with Fresh Candidates list.

A candidate is permitted to apply for improvement in any paper of the particular year within 30 days from the date of announcement of results of that year **with Prescribed fee of Rs.1070/- separately.**

Those candidates who are taking the Examinations for improving their Class/Marks etc. should have taken prior permission from the Registrar (Evaluation) before paying the examination fees for taking the Examinations as per regulations. Improvement is allowed only in Theory and Practical. However, the marks secured in the previous attempt is retained if the same is higher. There is no provision for improvement of internal assessment /Viva-Voce/Dissertation/Project/Field Work marks.

As per the University Circular No.RPS/Fee/2009,dated 12.11.2009, in respect of University Departments /Constituent Colleges /Students residing within BBMP area should pay the Examination fees to the University shall be by the way of crossed DD only drawn on any Nationalized Bank in favour of the Finance officer, Bangalore University Bengaluru. And payable only at State Bank of INDIA, Nagarabhavi Branch, Bengaluru. -560056.

This shall be remitted either at the City Finance Officer, Cellular Floor, Library Building, Central College Campus , Bengaluru.-01 or at the office of the Finance Officer ,Ground Floor, Administrative Building Room no .207, Jnanabharathi, Bengaluru.-56 and obtain an official receipt for the same. The said receipt issued as proof of payment of amount, shall be enclosed to the intended application compulsorily. Any other form of remittances like Cash, Cheque, IPO, Bank Challans, Money Order, Mail transfer etc., are not accepted.

The Directorate of Correspondence Courses, BUB, is requested to contact concerned Chairpersons of the Bangalore University Departments regarding arrangement of Examination Time Table.

Note :- Improvement fee is in addition to the prescribed Examination fee which has to be paid by the students who desires to appear for Examination to Improve their results. If he/she is eligible as per rules, with University Permission is required compulsory.

In addition to the prescribed fee for the Examination, the below mentioned amount has to be paid by all the candidates irrespective of the caste / category.

Out of scrutiny fee of Rs.10/- college may retain Rs.8/- and Rs.2/- to be credited to the University funds. The retained amount of Rs.8/- by the Colleges shall be utilized towards contingency expenditure including stationery and all other incidental expenses (except answer books and postages)/ **The Examination fee once paid will not be refunded or-re-adjusted under any circumstances.**

The Directorate of Correspondence Courses, BUB, is requested not to insist the students for those "FAILS IN AGGREGATE" to obtain the permission for improvement and request to the University accept the application directly as repeaters. The University will issue improvement permission only for the students who have passed the Examination/Subject and have obtained less percentage as per regulation.

As per resolution of Academic council decision dated held on 24.03.2018, the students who have completed their courses and could not complete their degree are permitted to appear for 1st / 2nd year M.A/M.Sc (Mathematics), M.Com.)Directorate of Correspondence Courses only) Examinations of August /September 2018 as one time measure subject to condition that they shall study and pass the examination as per the existing syllabus only.

Payment of Examination fee and submission of application for the Examination alone do not entitle a student to take the Examination, if he/she is not eligible as per rules/Regulations governing the eligibility.

Question paper indent shall reach the confidential section, on or before 21.08.2018 along with one set of candidate list failing which penal fee of Rs.5, 000/- will be imposed.
