

The above mentioned documents are to be submitted to Academic Section-I, Administration Block, Bangalore University, Jnanabharathi Campus, Bangalore -560056 on or before 10.11.2018, failing which a fine of Rs.5000/- (Rupees five thousand only) will be imposed and hall-tickets will be withheld and permission for writing exams will not be granted.
